



E-MAIL & FACSIMILE AUTHORITY AND INDEMNITY FORM

To: **Trelawny Co-operative Credit Union Ltd.**

From time to time it may be deemed convenient and in my interest if I could send instructions by means of electronic mail hereinafter referred to as “e-mail instructions” **OR/AND** by means of facsimile hereinafter referred to as “fax instructions” to Trelawny Co-operative Credit Union Limited (“TCCU”) in relation to any and all my existing account, facilities and other arrangements TCCU and any account, facilities and other arrangements which I may now or in the future have with TCCU. In consideration of this TCCU will agree to accept e-mail instructions **AND/OR** fax instructions from me as aforesaid, I agree as follows:

THAT TCCU may act on any e-mail instructions and/or fax instructions given by me from and I voluntarily and with full knowledge take and assume all risks associated therewith.

THAT in acting on e-mail instructions and/or fax instructions TCCU shall be deemed to have acted properly and to have fully performed all obligations owed to me, notwithstanding that such e-mail instructions and/or fax instructions may have been initiated, sent or otherwise communicated in error or fraudulently, and I shall be bound by any e-mail instructions and/or fax instructions on which TCCU may act if TCCU has in good faith acted in the belief that such e-mail instructions and/or fax instructions were given by me;

THAT once e-mail instructions and/or fax instructions have been received by TCCU purportedly from the person (or by any of the persons, if more than one) specified below, TCCU shall have no obligation to check or verify authenticity or accuracy of such e-mail instructions and/or fax instructions purporting to have been sent by me and may act as if same had been duly given by me.

THAT TCCU may, in its absolute discretion, decline to act on or in accordance with the whole or any part of an e-mail instructions and/or fax instructions pending further enquiry or further confirmation (whether written or via verbal consent) by me, so however that TCCU shall not be under any obligation to so decline in any case, and TCCU shall in no event or circumstances be liable in any respect for not so declining.

TO release TCCU from and indemnify TCCU against all claims, losses, damages, costs and expenses howsoever arising in consequence of or in any way related to TCCU having acted in accordance with the whole or any part of any e-mail instructions and/or fax instructions or having exercised (or failed to exercise) the discretion conferred upon TCCU in Clauses above.
